ON VOTING RESULTS OF SHAREHOLDERS' ANNUAL MEETING OF ARMENIAN ECONOMY DEVELOPMENT BANK OPEN JOINT STOCK COMPANY

Yerevan

June 14, 2019

The voting of the "ARMECONOMBANK" OJSC's (hereinafter Bank) Shareholders' Annual General Meeting was carried out by poll (Article 79 of RA Law on "Joint Stock Companies"). According to the Bank's Board Resolution No. 17/12-03.05.19, the voting bulletins were provided (delivered) to the shareholders before May 24, 2019. During the summary of the voting results, pursuant to the requirements of Article 77 of RA Law on "Joint Stock Companies", the votes provided by voting bulletins received before the end of the registration of participants were taken into account.

The voting results are as follows:

Distributed voting shares totals to 1,852,533 shares giving right to voting, from which 1,485,7036 votes or 80.16% of the total shares have participated in the poll.

6 voting bulletins with 1,396 voting right had been made invalid for not keeping the voting rules.

The quorum is secured.
