The voting of the extraordinary meeting of the shareholders of "ARMECONOMBANK" OJSC with remote meeting has been done by ballots ("RA law on Joint Stock Companies", Article 79). The ballots have been provided/delivered/ to shareholders till June 14 of $\mathrm{t} / \mathrm{y}$ in accordance with number 16/10-14.05.18 resolution of the Board of the Bank. When summarizing the results of voting the votes provided by ballots till the moment of end of registration of participants in accordance with the requirements of Article 77 of RA law "On joint-stock companies".
The results of summarizing the ballot papers are as follows:
The total number of votes of the allocated voting shares of the bank is $1,852,533$ shares giving a right to vote, of which $1,520,107$ voting shares or $82.06 \%$ of the total number of shares participated in the voting. 8 ballots with 101 votes have been declared invalid of the ballots taken part in the voting for violating the rules of voting.

The quorum is ensured.
