This information bulletin (hereinafter: Bulletin) defines the procedure of registration, service and other terms in "AEB MOBILE"/"AEB ONLINE" systems by the customers of ARMECONOMBANK OJSC(hereinafter: Bank).

Section 1. General concepts

- 1.1. System: "AEB Mobile"/"AEB Online" systems of the Bank;
- 1.2. "AEB Mobile" system: electronic system for providing services to customers/servicing of the customers without visiting the Bank through the relevant application of mobile devices;
- 1.3. <u>"AEB Online" system:</u> electronic system for providing services to customers/servicing the customers via the Internet without visiting the Bank;
- 1.4. <u>Client:</u> a physical(private entrepreneur) or legal entity;
- 1.5. <u>User:</u> Client or a physical entity represented by the client, who shall pass an appropriate process of registration in the System;
- 1.6. <u>User registration data:</u> login of the user (e-mail address), mobile phone number, one-time passwords, name, surname, date of birth, social card,
- 1.7. Role of the user in the system –authority entitled to the registered user. The available roles for PE/LE users in the system are as follows:
- **First or Second signatories**, who are entitled to approve the transactions, including to give payment orders, make transfers, withdraw amounts from accounts, conclude other transactions, submit applications, as well as make any other actions envisaged by the System. Moreover, if one user is registered in the System with the role of First and Second signatory, the latter can confirm transactions alone, and if more than one users have been registered in the System with the roles of First and Second signatory, then the transactions must be approved by both the First and Second signatories.
- **Creator**, who is not authorized to approve transactions, but can create documents with the aim of confirming by the First and Second signatories,
- **Observer**, who is not authorized to confirm transactions or create documents, but can view transactions, the accounts.
 - 1.8. <u>Client's identification data:</u> User's registration data, document containing the Client's public services number plate(in case of a physical entity(PE)client, and TIN in case of a legal entity(LE)client) and the customer's card number in appropriate branch on the OD system of the Bank.
 - 1.9. **OTP-** One-time password-Security code for entering the System ("AEB Online"), as well as for Confirming the transactions depending on the amount and type ("AEB Online" and "AEB Mobile");
 - 1.9.1. through an sms- consists of 4 digits,
 - 1.9.2. the user receives the password via the Token device received from the Bank, it consists of 7 digits.

Section 2. Registration of the Client in the system

- 2.1. The customer is registered in the System in accordance with the procedure set forth by this section.
- 2.1.1. The client submits an Application for being registered in Mobile Banking/Online Banking electronic systems of ARMECONOMBANK OJSC.
- 2.1.2. The user selects AEB Online link from www.aeb.am website (in case of "AEB Online" system) in order to use the System, or downloads the "AEB Mobile" mobile application(in case of "AEB Mobile" system).
- 2.1.3. In the window opened from the AEB Online page, in the Login window opened by the Login link, the user's email address specified in the Application is filled in, and in the Password field, the temporary password sent to the email provided to the Bank (for LE/Private Entrepreneur customers) is filled in, after which, upon completion of the User's registration, the latter receives access to the services provided to the Customer.
- 2.1.4. After downloading the "AEB Mobile" mobile application, the phys. entity customer is registered in the application
- 2.1.4.1 or applying to the servicing branch of the bank and filling in the email and the mobile number submitted to the Bank, the system administrator, by identifying the client, attaches the accounts to the User and the latter gets access to the services provided to the Client.
- 2.1.4.2 or passes Biometric Authentication:



- in case of being a customer, after passing successful authentication, the Physical Entity Customer gets access to services,
- in case of not being a customer, after successful authentication, the Physical Entity Customer registers as a customer and a bank account is opened for the Customer to gain access to services.
- 2.2 In case of receiving a temporary password from the bank, the User must change it in case of the first entry.

Section 4. Other terms and requirements

- 4.1. The system allows 6 failed login attempts.
- If more than five unsuccessful attempts are made, the access rights of the given user are temporarily blocked, if the correct password is entered again after 3 minutes, the user can enter, and in case of 6 consecutive unsuccessful accesses, it is blocked.
- 4.2. The Bank undertakes to block the access of the user in case the client is not identified, as well as in cases of the general agreement of providing bank services signed with the Customer, in cases defined by the general conditions.
- 4.3. The Client has a right to block the access right of the user to the system by applying the bank or changing the users.
- 4.4. In order to perform operations in the system, the fulfillment of requirements of the general agreement for the provision of banking services signed by the Customer with the Bank (if not signed, the Customer is obliged to sign it immediately or from the moment of registration in the System, the contract valid in the Bank is considered to be concluded between the Bank and the customer), fulfillment and storage of General Terms and Tariffs, as well as Customer identification are mandatory.
- 4.5. The Client's identification is the registration of the customer in the System as a User, after which the customer receives a login of the system user and a temporary password, with the use of which the Client is considered identified.
- 4.6. After the Customer's identification, the performance of any action and/or operation/transaction allowed by the System is considered a transaction actually performed by the Customer and/or on his/her instructions, and the information generated in the system regarding it acquires legal force and significance equivalent to a written document transaction signed by the Customer.
- 4.7. If the User is not the Client, then that User is considered an authorized representative of the Client with the role of the liability entitled to him/her in the Application of the Customer's registration and the operations executed by the latter are considered as operations made by the Client (the Client may terminate this right by notifying the Bank in writing).
- 4.8. The Client (user) is obliged to keep the secrecy of its passwords, not to disclose them to the third parties, not to give an opportunity for them to become accessible to other persons and take all possible security measures, and in case of any leakage or similar danger, change the given passwords in the system, contact the bank to suspend the Client's identification by their use and application.
- 4.9. In order to verify the Customer's identification, the System may introduce additional security measures (sending a one-time password via SMS to the registered phone number, and/or others), applying which the identification of the person entering the System and/or making transactions and the Customer is considered verified.
- 4.10. The bank undertakes to charge the Customer the commissions defined by the Bank's Tariffs for executing operations with the System, as well as other fees related to the service of the System by the third parties.
- 4.11. The bulletin is provided free of charge in paper form at the Customer's request, and is also available at all locations of the Bank's activity (the head office of the Bank and branches).
- 4.12. The Client may get acquainted with other terms of usage of the system through the Internet website of
- 4.13. The terms of the Bulletin may have amended after the date of publication of the bulletin, which the Client may clarify by contacting the Bank's means of communication indicated in the Bulletin.
